A. Cover Story

All Party Parliamentary Group on School and College Governance

Last year, an All Party Parliamentary Group (APPG) on School and College Governance was set up by twenty MPs and Peers. NGA acts as the secretariat to the APPG, which is chaired by Neil Carmichael MP. The aims of the group are to raise the profile of school and college governors, to explore their changing leadership role, to act as advocates for the importance of good school and college governance, and to ensure governors' views and concerns are heard in Parliament. It provides a very good way for governors to raise issues of interest with MPs.

The next meeting of the APPG is being held on Monday 21 May in the House of Commons. It will be used to consult parliamentarians and other interested parties on a draft of 'twenty questions' which can be used by school and academy governing bodies to review their effectiveness. The list, developed with input from both NGA and Ten Group, is intended to provide actions that governing bodies can undertake in order to improve practice.

Invitations will be sent to MPs on the APPG mailing this week. However, MPs are more likely to engage with the issues when a local constituent raises them, and governors who encourage their MPs to attend will be invited to attend themselves. B. Education News

1. School Funding

On 26 March, the Department for Education (DfE) issued its latest consultation on school funding (this follows from the two consultations that took place in 2011). The DfE has decided to make no changes until 2015 at the earliest to the way in which it distributes funding to local authorities. This is disappointing as the Department has recognised that the current system is inequitable and requires change. What the DfE is consulting about now are changes to local authority funding formulas from April 2013, i.e. the way in which local authorities distribute funding to schools.

The DfE is proposing that LAs will only be able to use ten factors to distribute funding to schools and that Special Schools and special units attached to mainstream schools will all be funded in the same way via a mechanism known as 'place plus'. Deprivation funding will in future only be distributable using either Free School Meals eligibility or the Income Deprivation Affecting Children Index (IDACI). Protection for small schools will be made through a lump sum allocation as there will be no allowable specific 'small school' factors and– this lump sum must be the same for all schools whether primary or secondary.

2. Need to Know Information for Governors and Headteachers

The Department for Education has released a document outlining the important information that is needed in order for headteachers/principals and governors to plan and implement changes throughout the academic year. They have also updated the myths and facts document, which addresses some of the misconceptions about bureaucracy.

3. Improving attendance

The DfE's expert adviser on behaviour, Charlie Taylor, has written a report on improving attendance, in which he says the Government should move its focus away from 'truancy' and concentrate instead on attendance, as 'truancy' is not the only cause of pupils' absence. The report makes 13 recommendations including that holiday in term-time rules are strengthened, parental fines are made easier to understand and that attendance statistics are produced for the whole year and included in Ofsted reports. 4. Michael Gove MP at House of Commons Select Committee

The Secretary of State for Education, Michael Gove MP, appeared before MPs of the Education Select Committee last week to give further evidence on a range of subjects, including school improvement and the national curriculum. He was asked about some of the issues that Her Majesty's Chief Inspector (HMCI), Sir Michael Wilshaw, had raised when he appeared before the committee in February, in particular what the middle layer between the DfE and individual schools should look like. The Secretary of State said that he was 'open minded' about any solutions, but that it had been shown that school to school improvement was one of the most effective methods, and he did not want another "bureaucratic" body, like some local authorities, to be put in place. He also revealed that eight academies had been issued pre-warning notices. He was also questioned about the curriculum, including sex and relationships education, on which he said: "If you look at the way in which we can encourage students not to engage in risky behaviour, one of the best ways we do that is by educating them so well in a particular range of subjects, that they have hope for the future."
