# A. TES and NGA Joint Survey

The results of the annual NGA/TES survey of school governors have been published. A record 2400 governors responded to the survey over two weeks in July. The proportion of respondents who are academy governors has risen by ten percentage points to make up a quarter of respondents. Of these, 35% thought that becoming an academy had improved educational standards, with another 35% saying it hadn't. More academy governing bodies seem to be making use of the flexibilities given to academies to alter teachers' pay and conditions – 21% had done so this year compared with 4% last year. This still represents a small proportion of academy governing bodies, but as one respondent commented: "The freedoms given to academies will take time to be introduced but will eventually help".

Just over half of respondents supported performance related pay, but a third said they didn't think it would improve pupils' attainment. Only 61% said they'd amended their pay policy as required for September. This should be done before teachers' objectives are set – NGA members can go to the <u>Staffing section</u> of the members' area for guidance on this.

An encouraging 80% of governors reported using a skills audit, with the vast majority saying they found it helpful. Although only 8% of respondents said they'd carried out performance management of governors by the chair or a third party, this is an encouraging start to relatively new practice adopted from the private and charitable sector.

Less than half of respondents said they'd carried out a governance review this year. Of those who have carried at a governance review, 81% said it had made a difference. NGA now offers a <u>consultancy and training service</u> – available to all governing bodies in England – which includes governance reviews.

# **B.** Education News

#### 1. Education leaving age raised

The government has increased the participation age (commonly known as the 'school leaving age') to which all young people in England must continue in education or training. From **September 2013 this rises from 16 to 17, and from summer 2015 it will rise to 18.** This means that pupils who left year 11 in summer 2013 need to continue in education or training until at least the end of the academic year in which they turn 17. Pupils starting year 11 or below in September 2013 will need to continue until at least their 18th birthday.

However, young people do have a choice about how they continue in education or training post-16. This could be through:

- an apprenticeship;
- full-time study in a school, college or with a training provider;
- full-time work or volunteering combined with part-time education or training.

Schools are responsible for securing independent careers guidance for their pupils in Years 9-11 (extended to Years 8-13 from September 2013). This should include information about the full range of post-16 options.

### 2. A Level and GCSE exam results

August saw the release of exam results for both A Levels and GCSEs. Analysis of A Level results by the Joint Council for Qualifications (JCQ) shows that the proportion of pupils receiving the top grades of A\* and A dropped by 0.3% compared to last year, but that the overall pass rate (A\* - E) rose slightly by 0.1% to 98.1%. The number of students opting to take science subjects has continued to rise, with these subjects accounting for 17.8% of all A Levels. A similar trend was seen in maths, but take up of languages continues to fall in all subjects except Spanish.

# 3. The DfE Statistical First Release on Special Educational Needs and NGA survey

At the end of July, the DfE published the Statistical First Release on Special Educational Needs (SEN) in England based on figures from January 2013. The analysis shows that the proportion of pupils with a statement of SEN has remained unchanged since at least 2009 (at 2.8%), but that the proportion of pupils who have SEN, but no statement, has decreased for the third year in a row to 16.0% (most of this is due to a decrease in pupils at School Action). 53.0% of pupils with statements of SEN are educated at mainstream schools compared to 53.7% in 2012), 39.6% attend a state-funded special schools, 4.9% independent special schools, 1.8% non-maintained special schools, and 0.7% pupil referral units.


How confident are you that the governing body and headteacher are prepared for the implementation of the new pay rules?

#### 1. Regional Conferences free for all governors:
