# A. GCSEs to be replaced with the English Baccalaureate Certificates

The Secretary of State for Education, Michael Gove, has announced that GCSEs would be replaced by new qualifications called English Baccalaureate Certificates. Speaking in the House of Commons, Michael Gove said that, although the GCSE qualification was designed with "the best of intentions," it was designed for a different age and world.

It is proposed that the new qualifications will be assessed by exam only at the end of the course. In addition there will be only one level as opposed to the current system of foundation and higher papers. The Secretary of State acknowledged that this would mean that some students would be unable to achieve a qualification. For these pupils schools would have to provide a detailed record of their achievement. In addition, it will be possible to take the qualifications at 17-18 rather than 16.

It is proposed that schools will start to teach the new qualification in English, maths and science in 2015, with the first students taking exams in these in 2017. Geography, history and languages will follow later. Competition will be ended between exam boards, with only one board providing each subject in the new certificate.

The DfE has launched a formal consultation on the proposals which will last for three months. The NGA will be responding and if you have any views please send them to <u>Philip</u> (philip.wood@nga.org.uk). NGA members will be kept up to date with any changes to GCSEs through the newsletter.

### **B. Education News**

#### 1. Pupil Premium

David Laws (Minister for Schools) and Nick Clegg (Deputy Prime Minister) announced at the Liberal Democrat conference last week that extra money would be made available to schools. David Laws announced that schools would receive a small increase in the Pupil Premium for this financial year from £600 to £619, but that from April 2013 the pupil premium would rise to £900.

Schools receive funding through the premium for every child registered as eligible for free school meals (FSM) at any point in the past six years and children in care who have been looked after for six months. There is a separate pupil premium allocation for children of service families.

Nick Clegg also announced two further tranches of money. The 'catch-up' premium will be paid to secondary schools for every pupil who arrives in Year 7 not having achieved the expected level in English and Maths at Key Stage 2. £500 will be available for each pupil. In addition, following the success of this year's summer school programme £50m will be made available to run the summer schools again during the 2013 summer break.

#### 2. Ofsted Inspectors to Recommend External Reviews of Governance

Under the new inspection framework that came into force in September, Ofsted inspectors will be placing a greater emphasis on governance. Ofsted has published subsidiary guidance for its inspectors which contains more information about the aspects of governance they should focus on. In particular, it notes 'Where governance is ineffective in a school judged to 'require improvement' and is graded three for leadership and management, inspectors should include governance in their recommendations for improvement.' Specifically, that the inspectors should recommend that "An external review of governance should be undertaken in order to assess how this aspect of leadership and governance may be improved".

The reviews will be tested during this term and only schools subject to a HMI-led inspection will undergo a review. Ofsted and the National College are working together to pilot the reviews, which will involve a National Leader of Governance or a National Leader of Education designated by the National College conducting a short review of the quality of governance at the school, and discussing with the school options for improving governance.'

NGA is involved in discussions with DfE and the National College about the detail of these reviews.
