# **B. Education News**

#### 1. Governance Debate in House of Commons

Wednesday 24 October saw the first debate on governance for over 18 months in parliament. The debate, secured by Neil Carmichael MP, covered a number of areas including: accountability, governance structures, training and payment for governors. The select band of MPs attending the debate all paid tribute to the work of governors and the important role they play. Neil Carmichael began by outlining his ideas for governing bodies to be smaller and more skills based. He stressed the key role of the chair of the governing body and that this role should, in his opinion, involve financial remuneration. A number of MPs questioned why there was no compulsory training for governors, something which the NGA has been campaigning about for many years. Concern was also expressed about the apparent accountability 'vacuum' created by the establishment of more academies and the lack of local oversight.

It was proposed that there could be a national 'recruit a governor' campaign. Elizabeth Truss MP, the new Under Secretary of State for Education and Childcare, in response also paid tribute to the work of the NGA and governors, noted the increased focus on governance in the new Ofsted framework and said the Government has no plans to pay governors. The Secretary of State for Education's comments about governance, made at the FASNA conference in July, were mentioned a number of times, with Ms Truss explaining that they were only meant to be a depiction of poor governance, rather than a statement of governance as a whole.

#### 2. Local school funding formula causing concerns

In some parts of the country, the effects of the amended local funding formulae are causing issues, especially in those counties which are less well funded; as the funding cake is smaller to begin with in those areas, whichever way it is cut, some schools will be receiving smaller slices than before. The NGA issued a <u>short statement</u>.

The DfE has responded to these concerns by writing to all Directors of Children's Services to provide clarification and reassurance about the school funding arrangements in 2013-14. The letter confirms that the Department will review these arrangements and will make further changes in 2014-15 if it finds that the long-term consequences for schools are unacceptable.

The letter also confirms that the Minimum Funding Guarantee (MFG) will continue to apply at -1.5 per cent per pupil in 2013-14 and 2014-15. To address the concerns that some schools and authorities have raised about a potential 'cliff-edge' in funding from 2014-15, the letter gives reassurance that an MFG will continue beyond 2014-15, although this falls in the next spending review period, there is no confirmation of the value of that MFG.

The Department hopes that this letter provides local authorities, schools, teachers and



governors with reassurance that the reform to the school funding system will be introduced very carefully. It can be found at:

#### 2. NGA Top Tip

Do you use a skills audit? The NGA has a model one that is available to NGA members. The skills audit is a valuable tool for governing bodies. It allows you to see what skills the governing body already has, but may not have known about and also enables you to assess what skills you might be missing. You can then use this to direct your governor training/development, or use it to advertise a position next time you have a vacancy. Don't just fill in the skills audit; make sure you make use of the results

The programme begins with a 360° review – where a number of people who work with you in different ways are asked to comment on your abilities against a range of competencies – which is called a diagnostic by the National College. This will help you to tailor the activities to suit you, with a mentor to support and guide you through the programme. Some of the programme will be available from the comfort of your own home and other aspects undertaken at your school. There will also be a number of face-to-face sessions at a local venue.

Currently we are preparing to deliver the programme at a price below the RRP of £350 across the East of England, but we are also able to work in other areas if local partners – local authorities, dioceses, teaching schools or other schools partnerships/alliances – invite us. Currently we are preparing to offer the programme alongside local partners in:

The federations need not be identified as we are interested in getting to the bottom of the role of key players and what motivated them. We are interested in talking to governing bodies who have found this a very difficult process as well as those who feel it has all been successful.
